



READ BEFORE SIGNING

IN CONSIDERATION OF my child/ward being allowed to participate in the Ska'moog Youth Flag Football event, the undersigned acknowledges, appreciates, and agrees that:

The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) to my child/ward from the activities involved in these programs are significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

1. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation; and,
2. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the program itself, I will remove my child from the participation and bring such attention of the nearest official immediately; and,
3. I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Ska'moog Youth; its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property incident to my child's involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
4. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
5. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, consent to my child receiving medical treatment which may be deemed advisable in the event of injury, accident and/or illness during this Event, and will repay all costs incurred by Ska'moog Youth and its Representatives in procuring medical treatment in the event of an emergency; provided, however, that this consent to medical treatment shall in no way be construed to mean that Ska'moog Youth or its Representatives are obligated to provide medical treatment in the event of an injury or medical emergency.
6. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, understand that my child may be photographed and/or recorded at this Event. I hereby irrevocably consent to and grant Ska'moog Youth the exclusive and unlimited right to use and reproduce any and all photographs, audio recordings, video recordings or testimonial accounts taken by Ska'moog Youth or any Representative that contain my child's name, image, voice, likeness or account, for any lawful purpose whatsoever and using any means available including but not limited to any Ska'moog Youth marketing communication or material. I waive the right to inspect, approve or edit any such use or reproduction, and Ska'moog Youth may make any and all changes, modifications, rearrangements, additions or deletions in its use or reproductions without any approval.
7. I, for myself, my spouse and my child consent to the reasonable inspection of my personal property before entering this Event. I agree and understand that the payment of my entrance fee grants me the privilege to participate only in this Event. I further agree and understand that if I: (a) engage in conduct that endangers other participants; (b) engage in conduct that is unsportsmanlike; (c) verbally abuse or taunt any other participant; or (d) use language that is offensive to a reasonable participant, I may be removed from this Event without the need for further cause. I agree and understand that my entrance fee to allow for my participation in this Event is not refundable under any circumstances.
8. I, the parent/guardian, assert that I have explained to my child/ward: the risks of the activity, his/her responsibilities for adhering to the rules and regulations, and that my child/ward understands this agreement.

I HEREBY ACKNOWLEDGE AND AGREE that I have read page one of this waiver.

I, FOR MYSELF, MY SPOUSE, AND CHILD/WARD, HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
