RELEASE AND WAIVER OF LIABILITY

(PLEASE READ THE FOLLOWING CAREFULLY AND SIGN BELOW)

In return for permission to use, access, and participate in game day activities for the 2024-2025 NFL season conducted at MetLife Stadium (the "Stadium") on [September 22nd, 2024] ("Skamoog"), I hereby release and agree (for myself, any minors for whom I am signing, and spouses, heirs, and others) not to sue the National Football League ("NFL") and each of its thirty-two member professional teams and clubs, including, but not limited to New York Jets LLC ("Jets"), NFL Enterprises LLC, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties, LLC, NFL Productions, LLC, NFL International, LLC and each of their respective parents, direct and indirect subsidiaries, affiliates, successors and assigns, and each of their respective shareholders, members, partners, officers, directors, employees, agents and representatives (collectively, the "NFL Entities"), and the successors and assigns of the NFL entities, and the owners and operators of the facilities in which the Event is being held, including without limitation, New Meadowlands Stadium Company, LLC (d/b/a MetLife Stadium), New Jersey Sports Exposition Authority (NJSEA), Metropolitan Life Insurance Company, Jets Stadium Development, LLC and each and all of its employees, subcontractors, sponsors, agents, affiliates, subsidiaries, parents, members, owners and lessees of the premises (collectively the "Releasees") from and for all present and future claims that may be made by me, my family, estate heirs, or assigns for injury or harm of any kind arising as a result of my participation (or for the minor for whom I am signing) in the Event and related activities, including claims for property damage, personal injury, or wrongful death arising, regardless of whether any such injury, harm or damage was caused in whole or in part by Releasees' negligence. I understand and agree that the Releasees are not responsible for any injury or property damage arising out of the Event, even if caused by their ordinary negligence. I understand participation in the Event may involve physical activity and certain risks, including but not limited to serious injury and death. I also understand that my participation in and/or attendance at the Event includes possible exposure to and illness from infectious and/or communicable diseases including, but not limited to, COVID-19 (together with any mutation, adaption or variation thereof), MRSA, influenza, and other infectious and/or communicable diseases. I acknowledge that the circumstances related to infectious diseases are constantly changing, that the guidelines are regularly modified and updated, and I accept full responsibility for familiarizing myself with them as necessary. **I am voluntarily and freely participating in the Event and knowingly agree to accept all such risks, both known and unknown, including but not limited to serious injury and death.** I also agree to indemnify and hold harmless the Releasees from all claims arising out of my participation and related activities. I grant the Releasees the absolute right and permission to make, reproduce, broadcast, or otherwise use my name and likeness in any photographs, films, videos, recordings, or other depictions or images in whatever form or media (or for the minor for whom I am signing) in connection with the Event throughout the world and in any and all advertising and promotion materials, in any manner or media whatsoever. I acknowledge that I, nor the minor, have no right of approval or compensation. I understand that this document is intended to be as broad and as inclusive as permitted by the laws of the State of New Jersey and agree that if any portion of this Waiver and Release is found to be invalid, the remainder will continue in full legal force and effect to the greatest extent permitted by law. I further agree that any legal proceedings related to this Waiver and Release will take place in the

State of New Jersey and that I hereby agree and submit to the personal jurisdiction of the state and federal courts in State of New Jersey in connection with any such legal proceedings. I acknowledge that I have read this Waiver and Release, fully understand its content and have signed below of my own free will. This Release and Waiver is valid for any date when the Event is held (in the event of rescheduling).

If you are signing for a minor, you agree to discuss this Release and Waiver with the minor, and you agree that the minor's attendance at or participation in the Event is your choice. You further release and waive any derivative claims that relate to or arise out of your child's attendance at or participation in the Event. You also give permission to use your child's name and likeness for any promotional use.
